Board of Trustees Meeting Minutes  
December 12, 2017

Supervisor Reinbold called the meeting to order at 7:30pm with all board members, except Daenzer present. Daenzer arrived at 7:40pm

Frahm moved to approve the November regular meeting minutes as presented. Huber supported. Motion carried

**Code Enforcement** – presented report. Board requested letters be sent to all issues on report, giving a two week notice.

It was noted permits were not pulled for the demolition of the broken wind turbine.

Jim Klingenberg submitted his resignation, effective 1/1/18. The Board would like to thank Jim for his years of service and wish him well.

**Planning Commission** – Solar & Sign Ordinance public hearing was 12/4/17; both were approved. The January 4, 2018 Public Hearing for L & L Excavating has been canceled. The Planning Commission will meet on Thursday, January 4, 2018 at 7:00pm for a possible ordinance change to allow for contractor yards in A-1 Districts.

**Fire Chief** – reported 1 Chimney, 1 MFR, and 1 PI run for November. Training was Fireground Ops and Communication. 1 firefighter will be added to the department by the end of the week.

Reese – reported 3 Medical, 1 PI, and 1 Chimney Fire run for November. It was noted that residents have been having a difficult time contacting Reese for burn permits.
