Supervisor Reinbold called the meeting to order at 7:30pm with all board members present.
Frahm moved to approve the January regular meeting minutes as presented. Huber supported. Motion carried

Supervisor – Outside light has been replaced. County Roads will be increasing our allocation by 20%.

Code Construction – 1 Electrical permit was issued in January.

Code Enforcement – presented report.

Fire Chief – reported 2 MFR, 1 Structural Fire, and 2 PI runs for January. Training was Fit Testing/PPE. Chief requested approval from the Board to enter into an agreement with Richville FD to use Blumfield’s washing machine for turn-out gear. The Board granted it’s approval.

Roethlisberger moved to set the reimbursable mileage amount for Fiscal Year 2018/2019 at \$0.545, per IRS guidelines. Frahm supported. Motion carried.

Frahm moved to appoint Brian Bills as the Township representative on the Construction Code Authority Group. Daenzer supported. Motion carried.

Huber moved to approve presented check register 25105 - 25134 and monthly EFT’s. Frahm supported. Motion carried.
