February 11, 2020

Frahm moved to approve the January regular meeting minutes. Huber supported. Motion carried.

Celeste Culver from DHT requested the Board to give DHT permission to transport medical marijuana.

Casey DuBay approached the Board to continue doing Cemetery Maintenance and to begin doing sexton work.

**Supervisor** – Due to increased illegal usage of the Township dumpster, a lock will be installed.

**Road Advisory** – Presented updated 2020 Road Program.

**Code Authority** – Reported 3 Building, 3 Electrical, and 1 Mechanical permits for January.

**Code Enforcement** – report presented.

**Planning Commission** – Reinbold moved to re-appoint Al Poellet for a 3 year term on Planning Commission. Frahm supported. Motion carried.

Roethlisberger moved to set the treasure's salary for 2020-2021 at \$17,382.00. Frahm supported. Motion carried.

Daenzer moved to set the per election compensation for the clerk to \$1,500.00. Frahm supported. Motion carried.

Roethlisberger moved to set the summer tax compensation for the treasurer to \$800.00. Frahm supported. Motion carried.

Roethlisberger moved to set the supervisor's salary for 2020-2021 at \$10,926.00. Frahm supported. Motion carried.

Roethlisberger moved to set the wage for deputies for 2020-2021 at \$12.00/hour. Frahm supported. Motion carried.
