Supervisor Reinbold called the meeting to order at 7:30pm with all board members present.

Frahm moved to approve the January regular meeting minutes as presented. Huber supported. Motion carried.
Huber moved to approve the February special meeting minutes as presented. Frahm supported. Motion carried.

Supervisor - The equalization multiplier for AG is 1.048 and for Residential is 1.014.

Road Advisory – Bradley Rd is scheduled for 2017

Construction Code – 1 Electrical and 2 Mechanical permits were issued in January.

Planning Commission – Quarterly meeting is Monday, March 13, 2017 at 7:00pm. 3 Board Members have terms expiring. Supervisor to contact members to see if they are willing to serve another term.

Fire Chief – reported 3 MFR and 2 PI runs for January. Training was Fit Testing. Pancake Breakfast was well attended!

Reese – reported 5 Medical, 1 PI, and 1 Wire Down run for January.

Clerk – Saginaw County will be ordering new election equipment soon. There will be no cost to the township!

Treasurer – The last day to pay taxes at the township is February 28, 2017.

Zoning Administrator/Code Enforcement Officer – Frankenmuth Township Supervisor has been given his approval of their Zoning Administrator covering for Blumfield in time of need. Supervisor Reinbold will confirm what type of coverage will be provided.

Reese Fire Contract – Much discussion ensued regarding the increased cost from Reese, how to handle paying for fire protection, and FOIA requests for information. Decisions will be made once the FOIA information is received.

Alarm System – The Board decided to go forward with replacing the current system with a new cellular system. Chief Brown will coordinate the replacement.

One street light in the township needs to be replaced. The Board opted to go with the free option.
