Board of Trustees Meeting Minutes  
March 6, 2018

Supervisor Reinbold called the meeting to order at 7:30pm with all board members present, except Huber. Frahm moved to approve the February regular meeting minutes as presented. Daenzer supported. Motion carried.

**Public Comment** – Several in attendance indicated odor coming from DHT again. Supervisor has spoken with several residents and business owners over the last week. DEQ will be investigating on-site on March 7, 2018.

**Road Authority** – Presented 2018/2019 budget. Supervisor to contact Buena Vista in regard to Reimer Rd. The Board was reminded of the need to have the road millage renewed this year.
