Board of Trustees Meeting Minutes  
May 8, 2018

Supervisor Reinbold called the meeting to order at 7:30pm with all board members present.  
Frahm moved to approve the April regular meeting minutes and April 26, 2018 special meeting minutes as presented.  
Huber supported. Motion carried.

**Supervisor** – Mosquito Control has begun aerial spraying.

**Road Advisory** - still waiting to hear about the bridge repair on Beyer Rd.

**Code Authority** – 1 Building, 3 Electrical, and 1 Mechanical permit was issued in April.

**Code Enforcement** – Board requested the issue on Bradley be pursued, even though some progress has been made.

**Planning Commission** – Public Hearing for change to ordinance usage table will be held on June 4, 2018 at 7:00pm.

Regular Quarterly meeting will be held immediately following Public Hearing.

**Fire Chief** – reported 1 Down Line, 7 MFR, and 2 Disregard runs for April. Training was CPR and SCBA Air Management.

Reese – No report was provided for April.

**Clerk** – The new voting equipment will be delivered May 17<sup>th</sup>!!

**Treasurer** – Has made changes to financial accounts. The Property Tax account has been moved to Frankenmuth Credit Union. Treasurer is looking at options to allow residents to pay their taxes at FCU in Reese.

Roethlisberger provided a quote from Zehnder & Associates to do payroll and reporting. Daenzer moved to contract Zehnder & Associates to do the payroll and reporting for the Township. Frahm supported. Motion carried.
